The mare owner must place a deposit in the sum of \$250.00, payable to Alden Equestrian Division, LLC, with the agent to ensure the return of the shipping container. When shipping retainer is returned in good condition, and all applicable fees are paid the \$250.00 check will be voided and shredded. If paid via Paypal, deposit will be returned electronically. \*For buyers supplying their own containers, we are not responsible for the integrity of your container. Stud Fee 2025: \$500 Buyer responsible for stud fee, booking fee, container deposit, chute fee (collection cost), and shipping or pick-up fee. Please check with the breeding farm to find out the shipping schedule for the stallion. Normal collection days are Mon, Wed, Fri. It is the mare owner's responsibility to confirm our breeding/shipping days. Mare owner or agent must give at least 24 hour notice of possible semen shipment and confirm shipment by 8am Central time day of collection. No guarantee will be made that cooled semen will be available on a given day. It is first call, first serve. Frozen semen is available if cooled semen is not. Every effort will be made to accommodate your mare's breeding timeframe; however, it is the mare owner's responsibility to keep in contact so that your veterinarian and ours can get your mare in foal on a timely basis. Failure to adhere to these arrangements may result in missed heats and delayed shipments at the mare owner's expense.

If breeding on a foal heat, licensed veterinarian must prepare mare before semen will be shipped. - All applicable fees: Booking fee, container deposit, chute fee, and shipping fee must be paid in full before any semen will be shipped. For the purposes of this agreement, unless otherwise specified for a particular mare, the breeding season shall begin February 15th and close July 15th of the year on this agreement. 2. A \$150 non-refundable Booking Fee must be returned with this contract. The remainder of applicable fees (collection fee, shipping fee, and container use deposit) (\$\_\_\_\_\_) is due prior to the first collection or shipment of semen. If the mare requires more than one collection of semen to settle, additional collection and/or shipping fees must be paid prior to any additional collections.

3. All parties agree that semen shipped under this contract provides for the registration of ONE foal, if

this shipment results in the birth of TWO foals a stud fee will be due within 30 days of foaling.

- 4. This donated service is good for ONE breeding season from the time of donation. If you require an additional year, a supplemental \$150 booking fee will be required.
- 5. Should the above-named Stallion die or become unfit for service before the conditions of this agreement are met, this Contract will be null and void, and the stud fee minus the booking fee will be returned.
- 6. All parties agree that semen shipped under this contract will be used only for inseminating the mare named above.
- 7. Should the above-named Mare die or become unfit for service before the conditions of this agreement are met, a substitute mare may be used upon approval of Agent.
- 8. All payments are to be made payable to Alden Equestrian Division, LLC.

#### RETURN PRIVILEGES/LIVE FOAL GUARANTEE

- 1. Mare must be examined by a licensed veterinarian at or before 50 days after last date bred, and Agent must be notified of her breeding status after each examination or all guarantees are null and void.
- 2. Should mare abort, absorb the fetus, or fail to conceive, return privileges are guaranteed in the current season (February 15-July 15). A substitute mare may be used upon approval of Agent. At the end of the current season, Owner has the option of rebooking in the following season, but contract is only valid for two full breeding seasons. If said mare does not settle within two breeding seasons this contract becomes null and void and all money paid is forfeited.
- 3. Should the Mare not produce a live foal (stands & nurses) from this breeding season, the Mare Owner is entitled to ONE return breeding privilege the following season. Rebooking in the following season will require additional applicable collection, container deposit, and shipping fees. A statement of the details of the Foal's death by a licensed vet must follow within 10 days or the guarantee becomes null and void. The stallion owner has the option to:
  - a. Re-breed the mare the following season only under the terms of this contract.
  - b. Accept a substitute mare under the terms of this contract for one season.
- 4. A licensed veterinarian must administer the semen on the day of delivery to mare owner or its designee, failing which the attached Live Foal Guarantee shall not apply.
- 5. Mare Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to her, by any cause whatsoever and, therefore, agrees to hold Alden Equestrian Division, LLC (or any person associated with Alden Equestrian Division, LLC) harmless for any and all damages associated therewith.
